

# PRIVACY POLICY

This privacy policy governs your use of the software application (herein referred as “Application”) for mobile devices that are created by EdZilla Software Technologies Pvt Ltd (herein referred as "us", "we", or "our"). The Application is educational software focusing on teaching mathematics, English and Indic languages. The application derives most of its content from the textbooks recommended for K-12 classes in India.
